## **Information on the Scholarship**

### **How are the winners selected?**

All Junior Company Foundation Scholarship recipients will be chosen from submitted scholarship applications. Any interested party should submit a completed application, one-page essay about themselves and what the scholarship will be used for and a letter of recommendation (not mandatory, but highly recommended), by the deadline of **Tuesday, March 31, 2015**.

An impartial committee will select the recipients by evaluating each eligible parties application. *Priority will be given to new recipients of this award.*

Applicants will be judged on:

- Clearly-stated educational objectives and goals
- Evidence of community involvement, including theatre related experiences

Scholarship recipients will be selected without regard to financial need.

### **What is the amount of the award?**

The Junior Company Foundation Scholarship will be a one-time payment determined by the Junior Company Foundation Scholarship Committee and Board.

### **What are my obligations and responsibilities if I am awarded?**

- Submit a letter of acceptance of the award
- Submit proof of college/class, etc. acceptance prior to disbursement
- Check will be made out to the place/person in which the scholarship is intended for (not the scholarship winner, unless proof is given they have already paid for such college/class, etc.)

### **Who handles Scholarship procedures?**

All phases of the competition, including selection of recipients, determination of the amount of the scholarship stipends and payment of stipends for scholarships are handled by the Junior Company Foundation Scholarship Committee with Board approval. All decisions are final.
